KEEP HENDY WOODS STATE PARK OPEN

Dear Chair Huffman, Chair Dickinson, and Members of the Committees:

The Anderson Valley Winegrowers Association represents 44 member wineries, 25 member vineyards, and 25 associate members – all of whom are asking for your assistance in keeping Hendy Woods State Park open. Our only local state park, Hendy Woods is located in Philo, in Mendocino County, and is currently planned to close on June 30, 2012.

Why do our members want the park to stay open?

Besides the obvious benefits to our community – allowing access to our only old-growth redwood grove, a swimming hole widely used by both residents and visitors, and the only public trails longer than ¼ mile in the area – closing Hendy Woods State Park would drastically affect local businesses.

In our small community, lodging is extremely limited. The few hotels and bed-and-breakfasts are often booked months in advance and are costly because of it. Most require two-night minimums. Hendy Woods State Park has 92 campsites and four cabins, used year-round and booked to capacity most weekends during the summer. It offers a great alternative to private lodging, especially for visitors with children, or those simply looking to explore the natural beauty of the region.

As the largest and most popular campground in the area, many of our winery customers stay at Hendy Woods State Park. They enjoy the park's facilities and venture out to taste wine during the day. Because they've spent less on a campsite, they often can spend more at local businesses.

Hendy Woods also attracts business to the area. Often, visitors discover Anderson Valley by camping at the park, and then find out about the many small, family wineries that populate our wine country.

By closing Hendy Woods State Park, a big portion of our business would simply go elsewhere. Our valley is isolated, and since 10% of the parks destined for closure are located in Mendocino County, there won't be many alternate options for camping in the local area.



As business owners, we understand and are sympathetic to the fiscal issues behind the park closures. However, in tough economic times like we're experiencing, we also ask you to consider the impact on our local businesses and local employment. Even future tax revenue would be put at risk by closing Hendy Woods State Park.
